WDNR LAKE GRANTS AWARDED! VOLUNTEERS NEEDED! by Anne Kretschmann

We are excited to announce that we were recently awarded several additional lake management planning grants and one additional early detection and response grant, bringing the total number of WDNR grants awarded to the Manitowish Waters Chain of Lakes to <u>SIX</u> since 2011. The state put such a high value on our chain of lakes that we were ranked first in the state for three out of four lake management planning grants that the Town Aquatic Invasive Species Partnership (TAISP) submitted thus far. The grants will expand our understanding of the health, functioning, and threats to the Chain and enable the protection and enhancement of our lakes for generations to come.

The Towns of Manitowish Waters and Boulder Junction have generously committed a portion of matching funds as a component of the grants. We **strongly** encourage all MWLA members to volunteer their time as well. The chain-wide grants we received require an in-kind match of either volunteer hours or cash funding. Thus, your volunteer time and boat hours help us fulfill our commitments. This decreases the amount of matching cash-out-of-pocket funding expense. Volunteering is as easy as walking down your shoreline and noticing what plants have washed up or keeping your eyes open for aquatic invasive species while you are out fishing or taking a pontoon ride on a sunny day!

The North Lakeland Discovery Center will host numerous trainings throughout the summer on how to volunteer and what to look for (June 8, 18, 20, July 16, and August 13). The Discovery Center is **always** willing to help you identify any potential AIS that you find in your lake and stream travels. Simply bring a sample by to show us, or take a photograph and email it to us. It's important to note that even if you don't see an aquatic invasive species, your time spent keeping your eyes open still counts. ## **'LAKE CAPTAIN AND DECKHAND' VOLUNTEERS COMBATTING AIS** by Anne

Welcome to a late, but gorgeous, spring in the Northwoods! We would like to remind you that it's never too early to start monitoring for aquatic invasive species. Invasive curly-leaf pondweed (CLP) is already about 4-5 feet tall!

Our 'Lake Captain and Deckhand' program has become recognized by the state for being an extremely valued component in the fight against AIS. In the summer of 2012, more than 400 hours of lake monitoring were reported by 'Lake Captains and Deckhands'! We are expanding this program which trains volunteers to monitor shorelines and areas where AIS are most likely found.

We emphasize the identification of curly leaf pondweed that is a prolific aquatic invasive plant usually found in waters less than 4 meters deep with a soft substrate. It begins growing early, under the ice, and usually dies by mid-summer which has the potential to create dissolved oxygen problems due to decomposition and algae. CLP was first detected in 2010 in the Chain by a volunteer 'Lake Captain' trained by our program.

## TREATMENT OF CURLY LEAF PONDWEED

Pretreatment surveys of CLP will begin in the very near future in areas of Island, Spider and Fawn Lakes, and in the Island-Spider channel. Treatment will follow shortly after depending on water temperature. Infested areas in Rice Creek are on hold for treatment while awaiting permission from the Great Lakes Indian Fish & Wildlife Commission.

Boaters of motorized water craft are strongly encouraged to avoid entering Rice Creek from Island Lake, and to immediately clean their props when leaving infested areas, especially Rice Creek and the Island-Spider channel, to minimize the spread of CLP.

#### YOU CAN HELP!


We are looking for additional help to do herbicide concentration monitoring directly after the treatment. It is pretty straightforward and will involve going out on a boat and taking water samples. This will help us tailor treatment in the future to be more successful. We also are looking for help to scuba dive and hand-pull any smaller infestations that we find throughout the season. We will provide the scuba gear to anyone interested in getting up close and personal with curly leaf pondweed!

## PARTNERING TO COMBAT PURPLE LOOSESTRIFE

On May 17<sup>th</sup>, North Lakeland School 7<sup>th</sup> o



graders, from Mr. William's Science class, partnered with the Discovery Center and the MWLA to dig, pot and net purple loosestrife for the Manitowish Waters purple loosestrife beetle-rearing bio-control project. Purple loosestrife, an invasive species, has an extremely effective biological control, the 'Chella' beetles which eat and weaken the plant, keeping flowers from forming.

The beetles are reared on the netted plants at the Discovery Center and released into larger, established infestations on the Chain. Mid-summer, volunteers also pull non-established smaller populations and cut flower heads to slow the spread through seeds.

Thank you to Elizabeth Sykes and the Manitowish Waters Stitch N Time group for volunteering to sew new netting for the purple loosestrife plants.

#### **REST LAKE DAM - Environmental Analysis Completed**

The Department of Natural Resources (DNR) has updated the Rest Lake Dam web page to include information on the recently completed Environmental Analysis (EA) for a new dam operating order. The Environmental Analysis Tab includes links to: Record of Decision; EA Certification; DNR's Responses to Comments and Formal EA Amendments.

With the EA completed, the Waters Program is preparing an updated operating order to reflect the broad public interests identified in the EA. Prior to finalizing an operating order, the DNR will hold an informational meeting this summer to seek public input on the draft order.

Updates regarding the Rest Lake Dam will also be posted on the Town and the MWLA bulletin boards located on the side of True Value Hardware Store.

Members of the Manitowish Chain Defense Fund (MCDF) along with representative members of the Town, met in Madison with State officials in February to discuss concerns about proposed changes to the operating order of the Rest lake Dam. Those attending the meeting came away feeling that their concerns had been listened to. John Godzdzialski, regional director of the Wisconsin DNR, recently stated that before issuing an order, they will be holding a public hearing in Manitowish Waters in mid-July.

#### **FISH CRIB PROJECT**



Twelve new fish cribs will be placed in Little Star Lake late spring or early summer through the efforts of MWLA Board member Tom Kramer and his crew of volunteers. Due to the late spring, road weight limits are just recently coming off allowing for the logs to be ordered and shipped. When the logs are delivered, the cribs will be constructed and placed in Little Star Lake. Tom will provide GPS coordinates for the new cribs after they are placed and will then be posted on our website. ## WATER SAFETY PATROL NEWS

Thank you to Jack Arndt for his 10 years of service as Water Safety Patrol Officer on our chain of lakes. We wish him the best in his retirement as we welcome Dan Cardinal, Jack's replacement.

Please follow all boating safety rules this summer. The State of Wisconsin passed a law in the spring of 2010 prohibiting all boats from operating at greater than Slow-No-Wake (SNW) within 100 feet of all shorelines. (The distance requirements for Personal Water Craft (PWC) remain at 200 feet.) This is important to remember when operating through various 'narrows', close to islands, and in smaller bays. Per WI navigation law, SNW is defined as operating a boat at the slowest speed possible while maintaining steerage.

There are important age requirements for the operation of various watercrafts: A PWC cannot be operated by anyone younger than 12 yrs. of age, and, juveniles 12 through 15 yrs. cannot operate a PWC unless they have completed a DNR Boating Safety course and have the certificate with them.

All persons operating a PWC or boat, even if over 15 yrs. of age and who were born after Jan. 1, 1989, must complete a DNR Boating Safety course and have the certificate on board. Where a PWC is involved, a parent, guardian, or other adult, cannot ride along as a passenger, overseeing a juvenile operate the PWC, when that juvenile has not completed the required DNR boating Safety Course.

#### Safety Concerns:

- Do not ski 'after hours', (which is 7:00 PM by local ordinance), do not ski without an observer onboard, and, do not ski within 100 feet of a dock, raft or official swim area (includes picking up and dropping off skiers).
- When on the water after legal sunset, be sure all required navigation lights are on and are not obstructed by boat covers, bimini tops, etc.
- Personal Floatation Devices (PFDs), "Life Jackets", all boats, even paddle boards, are required to have a Coast Guard approved wearable PFD onboard for every person on board; and, PFDs must be size appropriate (child size for child, adult for adult, so forth). A cushion or life ring type only qualifies as a "throwable" and is required on any boat 16 feet or longer.

The Manitowish patrol boat is dispatched through the Vilas County Sheriff Dept. at 1-800-472-7290 non-emergency, 911 emergencies only. Let's all work toward a fun and safe boating season. Any questions, please call the Town Hall office, the WDNR, or visit the WDNR web site.

### **DID YOU KNOW?**

Yard waste does not belong in the water! It has come to the attention of the MWLA that
property-owners have been observed raking their leaves and pine needles into the water.
Dumping of yard waste into Wisconsin waters is prohibited. Please dispose of your yard waste
appropriately; it should not be dumped into our rivers and lakes! If you see someone raking
yard waste into the water, please inform them of the following rule:

PERMITS REQUIRED: Unless an individual or a general permit has been issued under this section or authorization has been granted by the legislature, no person may do any of the following:

- (a) Deposit any material or place any structure upon the bed of any navigable water where no bulkhead line has been established.
- (b) Deposit any material or place any structure upon the bed of any navigable water beyond a lawfully established bulkhead line.
- A study of the bats of Wisconsin is being conducted. Information is needed on the location
  and size of bat colonies. White-nose syndrome is a fungal disease that is lethal to bats... this
  unprecedented disease is currently spreading toward Wisconsin and severely threatens cavebat populations. If you know of large numbers of bats in caves, mines, barns, bridges,
  churches, schools, or other buildings, please contact the Wisconsin Bat Program at

- Construction has started on the newest portions of the bike trail system. Phases 2 and 3 will be completed from Red Feather Road to North Lakeland School. Manitowish Waters Bike Trail, Inc. is continuing its fund-raising efforts while these phases are being completed. To date, construction on all of these phases has been accomplished solely with private donations. The ultimate goal is the Hwy "K" connection to the Boulder Junction/ Sayner trail system, making Manitowish Waters a trail system destination.
